**Parental and Family Engagement Plan 2023-2024 Overview**  
**Title I, Part A– Every Student Succeeds Act (2015)**

Morgan County School System is dedicated to creating strong partnerships between the schools, homes, and community members of Morgan County. This partnership encourages positive relationships between families and the schools' faculty and staff, leading to academic success for all students. However, Morgan County Schools also wants to address the social-emotional needs of our students through parental engagement. This plan was developed with the whole student in mind and ways to engage families constructively in the school community. This plan will be reviewed every year in the Spring at our Federal Programs Advisory Council meeting. All committee members are invited to attend and contribute to the plan. Families are encouraged to visit the school(s) and partner with them and the district to strengthen the mission of parental and family engagement for higher academic achievement and the social and emotional well-being of all children.

**Parental Engagement**

Each year, parents are invited to review and make suggestions for the Title I plan. They also have the opportunity to contribute to and develop the schoolwide plan. At the beginning of each school year, parents are given the opportunity to hear their rights as Title I parents and how they can be involved in the planning process. Every school receiving Title I funds conducts a survey to assess the needs of parents and families in the school system.

Morgan County Schools sets aside 1% of its Title I allocation for parental and family engagement. Of that 1%, 10% is allocated to system-wide initiatives, while the remaining 90% is divided among the eight Title I schools of Morgan County. The amount given to each school is based on the student population.

The Morgan County School System created a parental advisory committee with representatives from each school, the community, and district representatives. The responsibility of this committee is to create opportunities for parents to be educated on ways to holistically help their children, how the school system works, and to disseminate this information to other parents. The committee meets multiple times a year.

The goals of Morgan County Schools Parental Engagement Department are:

- Build a support system between parents and school employees to better advocate for the whole student.
- Create partnerships among schools, parents, and community members to work together to further student achievement and development.
- Empower parents with information on how to help their students achieve academically, socially, mentally, and emotionally.
- Embed parents and community members into the school community.

A Title I Advisory Committee meets annually in the Spring to develop, review, and revise the plan. Invitations are sent to all schools, private schools, board members, parents, and other community stakeholders. The final product is then placed on the board agenda for approval and made available to all parents. MCS uses Annual Parent Survey results and other feedback opportunities from meetings to report and provide information for any needed changes. All schools hold Annual Title meetings and report any needed information to the LEA. Parents are invited to attend all planning and developing opportunities for all plans and are encouraged to be an active and engaged tool in their child's education. Evaluations and feedback are strongly encouraged from our parents and stakeholders.

MCS has two full-time bilingual aides and also contracts with other individuals on an as-needed basis.

MCS will involve parents of children served in Title I, Part A schools in decisions about how funds reserved for parental and community engagement will be spent at the district and school level.

When planning Parent and Family Engagement activities at the school level, MCS will coordinate and integrate with ALL other relevant resources possible. Fall survey results are used for planning at local schools and at the district level to serve, provide, and support any parent/family engagement needs as requested. Title schools use their parent teams to decide how the local parent engagement money will be used. When planning these opportunities, all funding sources are considered and budgeted.

A survey is conducted annually at all Title I schools. Survey results are used to evaluate the content and effectiveness of the Parent and Family Engagement Policy. Parents are asked to identify any barriers to parental involvement and engagement that exist. Survey results are used to improve our Parent and Family Engagement Policy and to enhance our parent and family engagement activities. If barriers are identified, the administration will work to address the issue. Communication will be in a language parents can understand, and all schools have access to translators/interpreters when needed.

**(ii) the needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers**

A survey is conducted annually at all Title I schools. Survey results are used to identify specific needs that families have in order to assist their children academically. Schools host parental engagement activities where parents are provided information and materials to use at home. Parent conferences are encouraged, and all schools have parent outreaches during the months of September and February.

**(iii) strategies to support successful school and family interactions**

Teachers are encouraged to have numerous and varied interactions with families. Teachers communicate regularly using e-mail, text messages, newsletters, phone calls, parent-teacher conferences utilizing the school parent compact, and other means. All information is provided in a language parents can understand.

A survey is conducted annually at all Title I schools. Survey results are used to evaluate the content and effectiveness of our parent and family engagement efforts and to determine if revisions are needed to our policies. Anything considered a barrier to parent and family engagement will be discussed and changed when needed. MCS continually strives to involve parents and our community. Evaluation of programs in the Spring will help drive direction for changes that need to be addressed and/or changed.

Both the LEA and local schools will involve parents, family, and the community stakeholders to comprise the advisory board for the purpose of developing, revising, and reviewing the parent and family engagement policy. Local school parent teams meet several times each year, and the LEA teams meet in the Spring unless a called meeting is necessary.

In an effort to assist families in understanding State academic standards and assessments, MCS will: -  
Encourage schools to have parent meetings at various times of the day and explain academic standards and assessments.

- Provide assessment results in a language parents can understand, when needed
- Promote parent-teacher conferences where the School-Parent Compact will be utilized
- Send home progress reports and report cards as scheduled

Title I schools receive parent and family engagement funds. These funds may be used to purchase materials for families to use at home. The outcome of the Fall survey determines the allocation of funding. Information is sent home at the beginning of each school year about literacy training and the use of technology. Some schools hold technology workshops for parents if that is on the needs assessment.

MCS communicates with all schools regarding the importance of parent/family communication and engagement. The LEA will promote and encourage the use of parent and family volunteers following a background check. Some form of parent outreach is scheduled monthly at each title school whether it be Parent Advisory, PTOs, meetings, etc. Sign-in sheets are kept on file at individual schools. Parents also participate in the annual title meetings both at the schools and the district.

**programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.**

Parent and Family Engagement is always a priority in the MCS. When planning parent and family engagement activities at the school and district level, all local, state and federal funds are considered and budgeted. Title schools have parent engagement money that their parent teams plan and budget along with other monies from other funding sources. All preschool programs are invited to attend events, and many times the funds are spent to build and maintain parent resource centers and parent supplies for family checkout to help their children.

To ensure that parents receive information in a language they can understand, MCS:

- Utilizes TransAct for parent notices in multiple languages
- Employees two full-time bilingual aides (Spanish) as well as contracted services with several individuals who provide translating on an as needed basis
- Publishes an English and Spanish Student Handbook for grades K-12
- All school websites can be translated to different languages
- All home communication is sent home in a language families can understand

Parents are always encouraged to give input as to how to best enhance our parent and family engagement activities and resources. All requests are considered, and decisions are based on funding, needs assessment, and survey results. A parent's voice is always heard and encouraged throughout MCS.

When applicable, parents may be involved in developing educator training when a variety of perspectives are desired. Parents may be utilized to provide feedback that will be used to improve training effectiveness.

Title I funds may be used for supplemental funding when all other funds have been exhausted.

MCS encourages parents to get involved and support their child's local school. Parent outreaches through PTOs, family nights, and other activities have parents reaching out to other parents for involvement.

In an effort to reach as many parents as possible, schools offer meetings and training at a variety of times according to Fall survey results. Home visits are conducted as needed. MCS also uses PACT and FACT, which are community resources, who provide assistance and will team with our school leaders for meetings and home visits.

The LEA will conduct studies with school teams to help identify types of schools, various outreaches to parents, activities and strategies that could be used to improve parent engagement. These tools will be implemented as they fit each school's needs. The most effective seems to be any program or activity that the child is a part of for the event.

A district parent advisory board meets annually. Members are invited by school principals and should represent the school demographics. The advisory board reviews the parent and family engagement plan and provides input on all matters related to parent and family involvement.

Community-based organizations and business are always solicited and encouraged to be partners in parent involvement activities. Our PACT/FACT workers already have networks in place with these agencies so that the needs of our students and families can be met quickly. We all work together to remove any barrier a parent/family might have that would inhibit them from participating or being a part of their child's education and any activities the child might participate in during the school year.
