

MINUTES OF THE MORGAN COUNTY BOARD OF EDUCATION

MAY 13, 2021

The Morgan County Board of Education met in regular session at the Office of the Board on May 13, 2021 with an advertised start time of 6:00 p.m. A work session preceded the business meeting.
